4. Performance

4.1 Standard Test Condition

The battery shall be evaluated within 1 month from the arrival date.

Unless otherwise stated in these specifications, the following test shall be carried out in an ambient temperature of $20\pm5^{\circ}$ C, relative humidity of $65\pm20\%$.

Discharge capacity when the battery is discharged at 7 A to 10 V after being standard charged. Five cycles are permitted for this test. The test shall be terminated at the end of the first cycle which meets the requirement.

4.2 Testing Instrument or Apparatus

4.2.1 Dimension Measuring Instrument

The dimension measurement shall be implemented by instruments with equal or more precision scale of 0.01 mm specified.

4.2.2 Voltmeter and Ammeter

Voltmeters and ammeters shall be equal or more precision instruments of 10 K Ω / V and 0.01 $\Omega.$

4.2.3 Impedance Meter

Impedance shall be measured by a sinusoidal alternating current method (1 kHz LCR meter).

4.3 Standard Charge

Standard charge means charging for 6 hours using 14.6 V/7 A charger.

4.4 Standard Discharge

Standard discharge means discharging at 7 A down to 10 V.

4.5 Electrical Performance

5. Mechanical Performance

7. Warnings
